

- Draft **Heat in Buildings Strategy** published for consultation in February 2021.
- Sets out actions and proposals for transforming our buildings and the systems that supply their heat ensuring all buildings reach **zero emissions by 2045**.
- **Energy efficiency is priority** across all pathways and technologies and is critical to unlocking deployment of zero emissions heating systems.
- **£1.6 Billion** of capital investment in next five years to build upon our existing support programmes and provide initial stimulus.
- By 2025 develop a **new regulatory framework** for zero emissions heating and energy efficiency to ensure that all buildings are energy efficient by 2035 and use zero emissions heating and cooling systems by 2045.



Scottish Green Public Sector Estate Decarbonisation Scheme

- Commitment to invest a minimum of £95 million capital over next five years in decarbonising Scotland's public buildings through Scottish Green Public Sector Estate Decarbonisation Scheme.
- Scheme brings together existing financial support with new support for Central Government.
 - Scottish Public Sector Energy Efficiency Loans Scheme
 - Scottish Public Sector Non-Domestic Energy Efficiency Procurement Frameworks and Project Support Unit
 - Scottish Central Government Energy Efficiency Grant Fund



Scottish Green Public Sector Estate Decarbonisation Scheme

- Scottish Public Sector Energy Efficiency Loan Scheme delivered by Salix Finance.
- Interest free loans for Local Authorities, ALEOs and Universities.
- Over 950 projects have been supported to date with total capital value of over £70 million. These projects have resulted in £11 million annual savings and 46,000 tonnes annual carbon savings for public bodies.
- In 2021/2022, an additional £10 million capital will be available to eligible public bodies with increased maximum 75% intervention rate offered along with increased pay back criteria.



Scottish Green Public Sector Estate Decarbonisation Scheme

- Public Sector Non-Domestic Energy Efficiency Frameworks (NDEEF) and Project Support Unit (PSU).
- Two National Procurement Framework Agreements for the provision of Non Domestic Energy Efficiency (NDEE) capital installations for public and third sector projects under £1 million capital and projects over £1 million capital for the Scottish public sector.
- There are a number of pre-approved suppliers for retrofit of public sector and third sector buildings with energy efficiency assets using Energy Performance Contracts to guarantee carbon and costs savings.
- The Project Support Unit (PSU), run by Mott MacDonald, supports users of the NDEE frameworks to develop documentation and issue tenders for available services and supports Framework public bodies through the implementation of their retrofit projects.
- Funding support of up to £50,000 per project is available from Scottish Government for PSU services.



Scottish Green Public Sector Estate Decarbonisation Scheme

- Scottish Central Government Energy Efficiency Grant Fund
- Grant support for Scottish public bodies classified as Central Government to improve the energy efficiency of their buildings and install low and zero carbon heat systems in buildings.
- June 2021 – Call for Applications for £1 million resource fund for pre-capital support with outputs to be delivered by 31 March 2022. Supported project are expected to apply for available capital support between 2022 and 2026.
- June 2021 – Call for Applications for £7 million capital fund for projects that can be delivered by 31 March 2022.
- October 2021 – Call for Applications for capital projects, including multi-year projects that can complete installation between 1 April 2022 and 31 March 2026.
- Further opportunities to apply for funding will be provided dependent on demand.



- Replacement Low Carbon Infrastructure Transition Programme launch in Autumn 2021.
- Provides pre-capital and capital support for large scale projects with energy off-takers.
- £400 million budget over next five years.
