## **STRATEGIC UPDATES**

#### **COSLA**

COSLA's update focussed on the current Parliament <u>Inquiry</u> - Local Government's ability to deliver on net zero policy. This meeting clashed with <u>COSLA Annual Conference</u> and a written update was provided as follows.

COSLA had an informal session with the Scottish Parliament's Net Zero, Transport and Energy Committee on 7 Dec 2021, to help inform the inquiry. Full inquiry is still ongoing, and COSLA is noting strong representations made by a number of LAs. COSLA may give formal evidence towards the end of the inquiry, and will put another report to the last meeting of the COSLA Environment and Economy Board in April, before May elections, to strengthen their formal position.

<u>The COSLA position</u> captures the key elements that COSLA are aware of that are of concern to LAs. COSLA is very keen to have comments and observations from members of the SSN LA forum, on this position, and to hear if there are issues they would like to see added to the position.

**COSLA Excellence awards** have a dedicated NZ/Just transition category (Category 5: Just Transition to a Net Zero Economy).

**Post meeting note**: Congratulations to West Dunbartonshire Council Partnership (Regulatory & Regeneration).

#### SCOTTISH GOVERNMENT

**Public Engagement Strategy** – key role for LAs to deliver trusted messages. Scottish Government keen to host a meeting with more LAs present. **Action SSN to follow up with SG**.

**Decarbonisation in public buildings (2038 target)** – no date set for consultation as yet. **Heat Network Fund** launched £300m capital grant funding (across public & private sector).

**NZ Inquiry**: Minister, COSLA and LAs likely to give evidence. Expect final report before summer recess providing guide to where future action needs to be focussed.

**Green Growth Accelerator (GGA) Fund (jody.fleck@gov.scot)** - £200m capital investment in low C infrastrucuture – <u>6 pathfinders LAs</u>. Encourage LAs to start to think about potential projects that could be eligibile for GGA now and to reach out to pathfinders organisations for information/funding model etc.

**Regional Climate Action Hubs** – to be established, with sessions planned over next few months as to how Hubs may be set up. See <u>link</u> for sessions & dates. Process to be community owned. For those interested please contact <u>ClimateChangeEngagement@gov.scot</u>

**LA engagement directly with SG** – SG keen to to engage with LA on NZ and other key players within LAs for SG to engage with e.g. other networks, gaps that the LA Forum doesn't cover.

#### SSN UPDATE

Key highlights 2021/22: SG/SSN guidance, Annual conference Dec 2021. 100% PBCCD submission record.

**Looking Forward:** Scottish Parliament Inquiry; work with Audit Scotand, May 25th Reporting Event & SSN Plan going forward (Capacity building, Reporting & Leadership, SSN Manual, update on SSN hybrid funding model).

#### IS UPDATE

Working with SSN on IS's climate change plan, keen to work with LAs to provide external voice.

**Skills, Capacity & Capability:** working with SLADE and what is needed.

**Carbon Literarcy:** worked with SCA to deliver training to elected members and now focusing on senior management with a "train the trainer" add-on.

**Elected member induction** - preparing a short briefing. Do contact IS if want to input to briefing and with any other actions/information that would be useful.

**Data & Research:** bridging gap between academia and practitioners. IS colleagues in the Gazetteer are keen to run a session on using address data can help climate challenges.
